I am currently the Dean of the Institute of Law in Jersey, sole higher education institution to provide legal education in both jersey law and English and Welsh law in the Channel Islands. I lecture undergraduate (UG) and postgraduate (PG) students on Common Law Reasoning, Comparative Law, Comparative Public Law, UK and French Public law, Jurisprudence and Critical Studies. I am also involved in many funded interdisciplinary and comparative international research projects.

A D M I N I S T R A T I O N

I was appointed at the direction of the Institute of Law, Jersey, in 2013 replacing prof. Andrew Le Sueur. I am in charge of the day-to-day management of the Institute (approx. 180 students LL.B UoL international programme, Jersey Law Course for advocates and solicitors, PhD) and its strategic and international development. During my leadership, I have increased the recruitment (from 7 to 40 per year; overseas recruitment), developed international partnerships with European universities (ENS Rennes, Universite de Toulouse 1, UAB Barcelona, University of Luxembourg, St Mary San Antonio, University of Manitoba), designed a LL.M in Jersey law, set up new campuses (Guernsey and Barcelona), started a Franco-English double degree (with Toulouse 1) and implemented a research strategy to make the Institute a research institution on small jurisdictions and mixed legal systems. I introduced blended teaching (including online via a YouTube channel) and flipped classes.

RESEARCH

My approach is strongly interdisciplinary and incorporates comparative methods, psychoanalysis and socio-legal perspectives. I conduct interdisciplinary, international and comparative research on judges and justice, courthouses and judicial ritual(s). I have also researched extensively on issues relating to constitutional theory and republicanism, mostly on the Constitution of the Fifth French Republic. Some of my articles on the 2004 Charter for the Environment, the third French bill of rights, have been well received and cited internationally on many occasions. Further to this single-country study of France, I research on multi-level constitutionalism in Europe with colleagues from UAB Barcelona and the Grup de recerca consolidat "Dret Constitucional Europeu". I mostly work though a comparative approach and have worked towards making the Institute of Law a research centre on the law of small jurisdictions and mixed legal systems.

• Presentation on the current and future position of the Jersey Law of Contract (October 2015 phase 1) £7,500 funded by Government of Jersey.

Phase 1 will involve various tasks including researching and review of alternative models of contract law reform, in particular the US restatement model and similar approaches in other jurisdictions (eg restitution restatement in the UK); researching and consideration of comparative law issues and adaptation of model to Jersey context; researching structure and style of drafting of restatement model. In terms of output, Phase 1 will result in the drafting and compilation of paper on contract law reform, including (i) an introduction to the Jersey law of contract; (ii) consideration of reform models, with emphasis on restatement approach; (iii) analysis of the objectives of a restatement and how it might apply in Jersey (including process); (iv) finalisation of a skeleton structure of contract law restatement; (v) exposition of proposed drafting style and an example of various provisions of a restatement.

The project studies the simulation of justice. The moot competition held in Jersey has been designed as a virtual court battle of 4 teams. A workshop on mooting took place before the competition.

'Effective Alternative Dispute Resolution in Administrative Proceedings: Advancing good governance in the administrative justice system (ADRADMJUST)'. European research project examining the role, the general framework and the empirical effectiveness of the main alternative dispute resolution tools (administrative appeals, mediation) in administrative matters, within the broader context of the administrative justice system.

The project ran in 2012 and 2013 and finished with an edited publication. I was responsible for the UK work, which added Essex to a network of twelve universities (Aix en Provence, Utrecht, Gent, Torino, Speyer, Madrid, Brno, Ljubljana, Poznan, Budapest, Copenhagen, Cluj Napoca).

• Sanction and Europeanization of Law: From a logic of sovereignty to a logic of regionalisation of the law (2009–2010); funded by the British Academy and the Centre National de la Recherche Scientifique Grants for British–French Joint Projects (University of Essex £2,500; UPOND €4,000).

Here, an international team examines the nature of sanctions in the European context of two 'large' legal cultures and traditions (UK and France). The study combines theoretical and socio-legal analysis. The overall objective is to fill a gap in the literature on sanctions by producing a comparative study on contemporary Europe. I am the UK project leader.

 A Comparative and Empirical Study on Unicameral Parliament: The case of Estonia and Monaco (2008–2009); co-funded by an Academic Purposes Fund Award of the Society of Legal Scholars (£400) and a British Academy Small Research Grant (£1344).

The project examined the causes and nature of the structure of legislative power in two small states (Estonia and Monaco). The first part of this project analysed the theoretical choice of single chamber design in both countries (inc. general principles and study of legislation), whilst the second part focused on why and how EU integration (Estonia) and Council of Europe membership (Monaco) had an impact on the institutional design. This gave me the opportunity to network particularly with the government and the judiciary of Monaco, and I expect future 'knowledge transfer' or consultancy work as a result.

• European Commission – Study on Member States' Legislation and Practices in the Field of Consular Protection (Sept. 2008–Dec. 2008); funded by the EU Commission (€4,000).

• Comparative project on legal certainty Essex/Nanterre. I have been invited to join a team of researchers from the Université of Paris Ouest Nanterre La Défense on a comparative project on legal certainty (2008–2011: €10,000; preparation of second part 2012-2015).

This project was funded by French institutions and administrative agencies, and included colleagues from Essex, France, Italy and the USA. It aimed to link economics and law in a case study of legal certainty (involving the transfer of commercial property). Conducted by conseiller d'Etat, prof. du Marais, the study was both theoretical and practical. I worked specifically on the theoretical aspect of the project with Professor JS Bergé.

As a result of my standing as an expert in both Public and Comparative Law, I was invited to provide the French input in a collaborative interdisciplinary and international project on 'Statelessness, Racism and Civic Exclusion: A comparative study of four European countries'. The research is funded by the Hanadiv Charitable Trust and the Ford Foundation Programme for studying and combating racism and anti-Semitism in Europe (Sept. 2006–Aug. 2008). Dir. Dr Brad Blitz, Oxford Brookes (£11,000).

This collaborative research project involved four research institutes from across Europe (Refugee Studies Centre and Centre for Research on Inequality, Human Security and Ethnicity at the University of Oxford; University of Oxford Brookes; Université du Sud Toulon Var, France; Faculty of Social Work, University of Ljubljana, Slovenia; Institute of International and Social Studies, University of Tallinn, Estonia). It examines the causes and nature of contemporary statelessness in two large states (UK and France) and two small states (Estonia and Slovenia). My own research focussed on the case of France. I made two contributions: one authored chapter on the theoretical aspect and the legal framework, and one co-authored chapter providing the results of empirical studies (interviews conducted with refugees and undocumented non nationals).

During this year, I was a researcher for the Université de Nice Sophia Antipolis and NGOs. The project concerned the environmental impacts of a motorway tunnel under a national park in France. Of Essex). EXCCEL is a partner in the European Internet Science FP7 project funded by the European Commission DG INFSO, commencing 1 December 2011. EXCCEL provides an opportunity to link together Essex Law School expertise in European and comparative law with other Faculty Centres. I am a founding member of EXCCEL and was appointed director in January 2013.

DIRECTOR, DOUBLE DEGREE SCHEME LL.B ENGLISH LAW AND MAÎTRISE (MASTER 1) EN DROIT

Having moved from a legal practice where administration and leadership were key skills, I became Director of the double degree scheme LL.B English Law and Maîtrise (Master 1) en Droit at the University of Essex. Under my supervision, we moved from recruiting only 15 first-year students to bringing in more than 90 students per year (approximately one quarter of the entire first year intake in the School of Law at Essex). I have also secured new French partners (Toulouse 1, Lyon 3, and Paris Ouest Nanterre La Défense) to diversify recruitment. In all, this is the most successful scheme of its kind in the UK and Ireland. Students graduate with two French Law degrees (Licence and Maîtrise/Master 1) and an English Law LL.B. Former students have been recruited to practice (in France, the UK, Spain and the USA), to the French judiciary, as EU civil servants, as academics, and to prestigious PG law programmes.

My duties included: development of the curriculum; long-term development of the scheme; day-to-day organisation; selection and management of GTAs/Adjuncts, and weekly coordination work with GTAs/Adjuncts and colleagues to ensure quality of teaching; recruitment and selection of international and European students (including direct selection

and recruitment of the students in France and the UK); pastoral care of returning third and fourth year students; monitoring of student results and employability; selection of teaching materials and organisation of examinations and rules of assessment; coordinating with our French partners and linking administrative teams in France and Essex; provision of a high level of pastoral care for our students. I was also Director of the following UG modules: French Constitutional Law, French Administrative Law, Comparative Law and Comparative Public Law.

In spring 2006, I devised and sought approval for this new PG scheme, which launched in October 2008. I was the Director or Co-Director of these PG modules/courses.

As Director of the Study Abroad programme for the School of Law, I developed new partnership agreements at UG and PG levels. At UG level, the Franco-English double degree was used as a model to develop new UG double degrees (primarily with Barcelona, Spain). At PG level, I developped a new 'double Masters' scheme (with the University of Potsdam, Germany, UAB Barcelona, Spain, and the University of Tallinn, Estonia). I have successfully integrated the School of Law at Essex as a research partner with UAB Barcelona in a European Master's degree in Law and Policies of European Integration: Constitutional Law and Multilevel Constitutionalism. I have also organised the institutionalisation of a link between our School of Law and the Turkish Ministry of Justice, with a view to receiving judges for training in EU law and prepared the way for a joint PG with the College of Law, American University, DC.
