
- EU Member States

- ✓ MICA and BA: 90 days left
- 2. Any student willing to graduate in 2021/2022 a. y. and interested in spending the traineeship months within 12 months after the graduation
- 3. Any student currently in Erasmus for study Erasmus study+Erasmus Traineeship allowed but not with overlap

4. Any student with a weighted arithmetic mean from 26/30 to 30L/30 (*Not allowed: 25,99/30*)

A. MONTHY GRANT PAYMENTS (EU amounts), awarded to all selected students for Erasmus Traineeships Mobility – CALL 2021, based on DESTINATION COUNTRY and corresponding to the following amounts:

Art. 4 – Financial support (National Erasmus+ Ag, MIUR and/or UniTO)

In order to award the Erasmus for Traineeship Call 2021 extra contributions, those who are in one or more of the following conditions are also considered as having an ISEE value of under €13,000:

- a disability of 50% or more;
- refugee status;
- subsidiary protection status;
- displaced person status;
- children of disabled claimants;
- foreign students with Italian Government grant;
- participants of projects where a convention or agreement totally exempts students from paying fees.

Warning: who did not send the ISEE documentation on time but could re-enter on art. 3.3 must send the ISEE document to the Central international office: <u>internationalexchange@unito.it</u>

before starting the Mobility or by 31 December 2021 at the latest.





C. "SPECIAL NEEDS" CONTRIBUTION

Additional EU contribution based on real costs for Mobility students with disabilities and special needs.

D. "TOP-UP TRAVEL GREEN" CONTRIBUTION

A contribution to support sustainable travel is available to encourage students to use transport that emits lower levels of Co2.





Contributions are paid <u>into the Participant's Italian or European bank</u> <u>account</u> provided the student has signed the international Mobility contract.

Payment is as follows:

- **1. First payment consisting of:**
- 100% of PART A monthly grant, by destination country;
- 100% of PART B extra monthly contribution for participants in disadvantaged economic situations, if applicable;

Payment will be based on when the international Mobility contract is received, duly completed and signed by the Participant.





Contributions received are subject to TOTAL OR PARTIAL REPAYMENT if:

- student refuses Mobility (refund of full amount);
- student does not submit their Learning Agreement for Traineeship;
- lack of correspondence between the type of Mobility (A or B) selected at the time of application;
- less time spent abroad than approved in the Agreement (refund of an amount corresponding to the number of days not spent abroad);
- Mobility abroad less than the mandatory minimum period of 60 days (refund of full amount).





 ✓ Students can do their internships at public or private institutions that sign a Letter of Intent with the student's University Department.

The organisation could be:

- ✓ a small, medium or large public or private enterprise (including social enterprises);
- \checkmark a local, regional or national public body;
- ✓ a professional or work representative, including Chambers of Commerce, craftsmen or professional orders and trade unions;
- ✓ a research institute;
- ✓ a foundation;
- a school/institution/training centre (any level from pre-school to secondary school, including vocational and adult education);
- \checkmark a non-profit organisation, charity or NGO;
- \checkmark a body for vocational guidance, professional advice and information services.

Each participating organisation must be based in a Programme Country.





The following are not eligible as Erasmus+ for Traineeship host locations:

EU institutions and other EU bodies including specialised agencies.

 organisations managing EU programmes, such as National Agencies (so as to avoid any conflicts of interest and/or double funding).

- Letter of intent or declaration of acceptance signed by the Institution (not determinant for SAA students);
- Internship project (project work) consistent with their curriculum (not determinant for SAA students);
- Other suitable" documentation to prove the language level of the country of interest (determinant for SAA students);
- Curriculum vitae in the language of the country of interest *(determinant for SAA students)*


